The temporary suspension of SNAP benefits created significant hardship for many members of our LOGAN family, especially those who already navigate daily challenges with limited resources. As the impact of the shutdown became clear, we heard directly from individuals, families, and staff who were suddenly unsure how they would cover the most basic needs like meals, groceries, and essentials that provide stability and dignity.

In response and with a grant from The Arc of Indiana, our team came together quickly and compassionately to organize a community-wide food drive, ensuring that no one within the LOGAN community had to face this difficult moment alone. Expansion of Pathways

LOGAN expanded its reach in 2025 with the opening of a new location in Elkhart, Indiana, which is now our second site in Elkhart County as our presence in the region continues to grow. This satellite location will operate within Riverview Adult Day Health Center and represents an important step in bringing high quality support services closer to the individuals and families who depend on them. Opening in September 2025, this new site reflects LOGAN's ongoing commitment to meeting community needs and increasing access to essential supports.

This initiative represents an exciting partnership between Riverview Adult Day Health Center and LOGAN Community Resources. Both organizations share a mission to improve the quality of life for people with intellectual and developmental disabilities. By placing LOGAN services within the Riverview campus, the collaboration expands access to vital programs and supports, creating a more integrated, convenient, and inclusive environment for adults with varying abilities, all within one location.

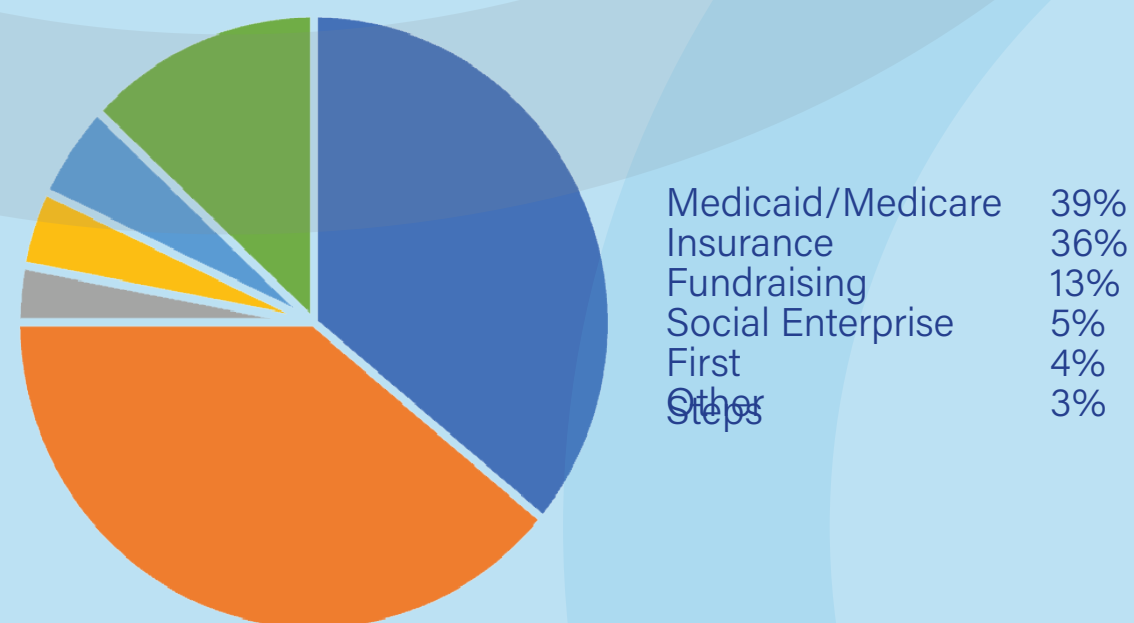
